## American Tax Receiptable Donation Form

American Fund for Charities 501 (c) (3)

The American Fund for Charities is a 501(c)3 tax-exempt organization that supports charitable organizations throughout the world. Cheques should be in dollars payable to The American Fund for Charities. The American Fund aims to give to charitable organizations at least 90% or more of donations over \$250, retaining funds sufficient to cover its administrative and program costs. The Board of Directors of the American Fund has determined that one way of ensuring that this target is met is to retain a percentage of each donation it receives and apply it towards its operational costs. The Board has determined that at this time it will retain a minimum of \$50 from each gift received, 7.5% of the next \$10,000 and 5% of the next \$90,000 and 2.5% of the remainder, with a maximum of \$10,000. The remaining will be forwarded to the HDMH Foundation.

The American Fund can accept donations of stock and shares. The policy of The American Fund is to sell stock it receives. The value of stock may increase or decrease and therefore the sale may realize more or less than the value when the stock was given to The American Fund.

Your tax receipt will be sent by The American Fund for Charities. Donations must be received by the end of the month preceding a quarterly Board meeting in order for a grant based on your donation to be considered at that meeting. The Board makes grants at its Board meetings will be the 15th February, 15th May, 15th August and 15th November. The American Fund for Charities is managed by Chapel & York Limited
